July 1995 or Driving the Dead, a Drug-Free Dystopia and Your Brain On-Line

The July meeting was held at the Bloodgood home, and even though there were no sales, publications or good rejections reported by the dozen or so attending members, when I asked

"Has anybody written anything?" plenty of hands reached for the sky, yessir.

Ben started the evening off with "This is Your Brain On-Line." Some software workers come to work one day and discover little brain icons on their Mac desktops. All the contents of their minds have somehow been translated onto the company's file server network. I enjoyed all the humorous possibilities, such as the site administrator/boss who decides she wants her "brain" optimized — and discovers she has a brain tumor (bad sectors?). Then, just as mysteriously as they appeared, all the brains disappear off the network.

Rocky read "Perfect World," a chilling shortshort that describes a near-future world that has gone to extremes in an effort to ban drugs. Drug users/traffickers, if convicted, are summarily executed. The problem is that the worldwide ban includes painkillers and drugs commonly used to treat diseases such as diabetes.

Warren read Chapter Four of his novel, Underland. In "Driving the Dead," Jack ponders his dramatic, fleeting encounter with the ghost (?) of Pamela and the mysterious woman in the Mazda as he makes his way back to the cabin. Could he love a resurrected Pamela? The next morning he tells Ed and Julie what has happened and together they resolve to track down the woman for more answers. Interestingly, it is hinted that Pamela's parents have a background in intelligence.

We heard chapters 2 and 3 of **Greg**'s untitled SF novel. We are introduced to Professor Joseph Halicari (sp?), a "hacker among hackers" who specializes in neurocybernetics.

Andrew, who apparently possesses some power that can injure others at a touch, convinces his sister, Mae, to allow him to work with her as she attempts to make connections with local drug dealers. A meeting is arranged, but Andrew discovers that Mae is really hunting for information that will lead her to a stolen high-tech weapon called Olympia, originally developed by Halicari.

#### DARK DIXIE WRITING CONTEST

1. The contest is open to entrants from all nations. However all stories must be in English.

All themes of sf, fantasy and horror are welcome. Every entry is judged on its own merits only. A \$10 (US dollars) entry fee is required. All stories will receive constructive critiques to help the author improve. All rights to entries remain the property of their artists. Entry fee checks should be made payable to MARIETTA PUBLISHING. Multiple entries are welcome, and each entry must be accompanied by a \$10 entry fee.

Entries should be mailed to: Marietta Publishing, 1000 Arbor Forest Way, Marietta, GA 30064. No phone calls please.

- 2. Entrants agree to abide by the rules of the contest when they enter.
- 3. The contest is open to any fiction writers, and will not distinguish between professionals and amateurs. Stories entered must be original works and previously unpublished in any media. Plagiarism will disqualify any entry and the entrant will be banned from the contest and any future contests. The top 3 winners are not eligible to enter the contest again in the future.
- 4. Prize winning stories will be published in some form of media, if the artist agrees to publication. After publication, all North American rights to the story will revert to the artist.
- 5. Entries must be typewritten and double spaced with each page numbered. Manuscripts should not exceed 8.000 words in length. Only prose writings will be considered. Poetry or fiction intended as children's stories will not be considered eligible. Manuscripts must have a cover page which includes the title of the work, the author's name, address, and telephone number, and an approximate word count. The manuscript itself should be titled and numbered on each page, but the author's name should not appear on the manuscript to insure fair judging.
- 6. Manuscripts will be returned after judging. Entries must include a SASE, and must be US stamped. Foreign entries may enclose international reply coupons.
- 7. There shall be 3 cash prizes per contest. First place of \$250, second place of \$150, and third place of \$75. All prizes paid in US currency.

Winners will receive a certificate declaring their winning position in the contest. An independent judge will judge the finalist entries. All decisions of the judges are their own and are considered final.

- 8. The deadline for entries is August 30, 1995. Winners will be notified by December 30, 1995.
  - 9. The contest is not responsible for manu-

scripts that are entered with no return SASE included. Such manuscripts will be disqualified and the entry fee will not be processed.

10. The contest administrator reserves the right to cancel the contest and refund the entrants' fees at any time.

11. The contest is void where prohibited by law.
